#### DISTRICT AND USF ASSIGNMENTS

The District and United Stewardship Fund assignments shall be 11.4 percent of the total income of a local church and all of its departments for the previous fiscal year, less money received (a) by loans (borrowed money), (b) by a bequest through a will, (c) all monies given to Global Partners and Wesleyan Native American Ministries, (d) and others as specified in *The Discipline* 2005:1.

**Building Project Adjustment** Whenever a local church engages in a major building project and fund drive which has been granted District Board of Administration approval, the involved local church may be granted permission by the District Board of Administration to have its United Stewardship Fund obligation adjusted to exclude the amount of money raised for said major building project or for a Debt Reduction Campaign.

**Wesleyan Pension Fund** The Pension Fund assignment is set at 12 percent of the basic salary and benefits for the pastor, associate and/or assistant pastors (if any), and 12 percent of the salary and benefits paid to evangelists who are members of the Wesleyan Pension Fund.

**Wesleyan World Missions/WNAM Adjustment** All giving to Global Partners and Wesleyan Native American Ministries will be adjusted from the base that will be used for figuring the USF Assessment.
